**An introduction to the types of
Law Firms in Thailand**

1. AN INTRODUCTION TO THE TYPES OF LAW FIRMS IN THAILAND

To assist one in choosing the right law firm for the job, a brief description of the law firms in Thailand is appropriate. Law firms in Thailand can be divided into the following categories:

i) Local Thai Firms

These are firms which engage in litigation as the bulk of their practice and constitute the majority number of law firms in Thailand. Their practice is monolingual for the most part.

ii) International Law Firms

These firms are subsidiaries or branches of their overseas "parents" and are often extensions of their parents' practice groups. They mainly advise on transactional work and foreign laws and through their network are able to provide "fly-in expertise" on particular projects. They do not usually engage in the practice of Thai law although increasing competition is forcing them to. These firms are what one would call "foreign law advisors" in jurisdictions such as Japan or Singapore where foreign lawyers are regulated.

iii) Multi-domestic Law Firms

These are law firms which are located in more than one jurisdiction and engage in the practice of law of the jurisdiction where they are located. They may or may not have an equity relationship with their other offices, but are essentially independent of one another, except for certain common policies, rules of practice and some "fly in" capability. The majority of their lawyers have law degrees from more than one country. Their practice may be regarded as "international" only in the sense that a significant number of their clients are foreign companies doing business in Thailand and they are conversant with transnational legal problems. In consequence, their practice is multilingual.

iv) International Accounting Firms

Many international accounting firms have established legal consultancy companies as an adjunct to their mainstream business. Even though these companies dispense legal advice they are not regarded as law firms in the true sense of the word.

We regard ourselves as a multi-domestic law firm (Category III).

The Firm In General

2. THE FIRM IN GENERAL

This law firm was founded by a U.S. attorney, Mr. Charles Warren Kirkwood, as a Registered Ordinary Partnership, in Bangkok, on 4 July 1966 and went through various transformations. The firm's first offices were in the BOAC building (now the site of Gaysorn Plaza) at the Rajprasong Intersection. The firm moved its offices to the South East Insurance Building, 315 Silom Road, in 1969, and then to the Bangkok Bank Headquarters Building on Silom Road in 1983. In October 1994, it moved to its present premises on the 18th Floor of Sathorn City Tower, 175 South Sathorn Road.

In November 1969, an international law partnership was formed by Messrs. Kirkwood, Kaplan, Russin and Vecchi incorporating the original R.O.P. At one time or the other, the firm had offices in North and South Americas, the Caribbean the Middle East and Saigon (closed down during the Vietnam War, but re-opened after the unification), Singapore and Jakarta. But some of these offices were closed down for various reasons.

In 1998, the Asian offices of the firm comprising Bangkok, Vietnam and Taipei, withdrew from the main partnership and focused its practice in Asia under the name of Russin & Vecchi (R&V). However, it still maintains a friendly alliance with the old partnership which now has offices in Washington D.C., New York, Santo Domingo and Moscow.

The purpose of the firm is to practice law and to give legal counsel and advice through offices located in various countries and staffed on a multinational basis.

INTERNATIONAL LEGAL COUNSELLORS THAILAND (ILCT) is the official name of the Bangkok Office.

ILCT is a member of Meritas, a network of 200 leading law firms in major cities of the world.

ILCT Practice Areas

3. I L C T PRACTICE AREAS

In Thailand, the firm is known as International Legal Counsellors Thailand, or "I L C T". With 9 resident partners and, as of these writing 15 associate lawyers, plus 19 trained paralegals, most of whom are multilingual, together with other support staff, we are 65 in number. With our over 51-year history, ILCT was one of the pioneer law offices engaging in the business law practice in Thailand. We have earned our reputation by consciously practicing in a group format and using personnel of diverse educational backgrounds to form teams to deal with each matter by applying maximum diversified expertise. By this method and through our inter-office matrix system, we have developed an internationalist approach and, indeed, the overwhelming majority of our clients have an international connection, whether by their make-up or by the type of transactions in which they are engaged.

We are a full-service law firm. Among the types of matters handled by our lawyers in Bangkok are the following:

3.1 Antitrust (Trade Competition)

Work in this field includes advising clients on compliance with the Trade Competition Act, especially the procedures to be followed in mergers and acquisitions. We also represent clients before the regulatory agencies concerned.

3.2 Banking and Finance

Work in this field includes advising banks, finance companies, insurance companies and the likes on commercial and regulatory matters; often in connection with advising these clients on how to structure their innovative financing products. We have helped structure new forms of loan, equity and quasi-equity transactions. We frequently are engaged to draft or review both local and international loan transactions, including the syndications, drafting of multicurrency loans, and the structuring and implementation of various forms of security for credit extended as well as with the creation of exotic financing and securitization instruments. We have dealt with loan work out situations. We have worked with more than 75 foreign financial institutions and their counsel with regard to their interests in Thailand, in one form or another. We also have been retained to represent borrowers, although this is relatively less frequent due to the probability of a conflict of interest.

We assisted among others with the Thai legal aspects of the global mergers of the Bank of Tokyo-Mitsubishi Bank and of the Chemical Bank-Chase Manhattan Bank, N.A.

All of our non-U.S. offices serve as general counsel to one or more local financial institutions or branches of foreign

financial institutions. It is common for the same financial institution to use our services wherever we are located.

3.3 Contract Negotiations

We assist clients in negotiating and drafting contracts of every type in Thai and English vis-à-vis private and government parties.

3.4 Corporate

Services in this field range from the incorporation and maintenance to dissolution of companies (private and public) and partnerships. They may also involve corporate restructuring (increasing and decreasing capital, etc.), converting private companies into public companies, merger and acquisitions. We specialize in localization of foreign companies and structuring joint ventures.

3.5 Corporate Recovery Services

We assist creditors and debtors in debt restructuring and in filing for re-organization under the Bankruptcy Act. We represented a group of the petrochemical companies in a US\$ 5 billion debt re-organization under the Act, the highest debt re-organization in Thailand.

3.6 Expatriate Services

Services in this area involve advice on laws and regulations on obtaining and renewing visas and work permits for expatriates and their families; advising on personal income tax planning; filing of personal income tax returns; obtaining of Tax Identity Cards, Customs Clearance Cards, Thai and International Driving Licenses, etc.

3.7 Factory and Environmental Regulations

We assist clients in establishing factories and complying with environmental regulations. The services include the acquisition of land and applying for factory licenses.

3.8 Foreign Business

Services provided in this field include advice on the structuring of investment and the obtaining of necessary permits for foreign companies to operate in Thailand in compliance with the Foreign Business Law.

3.9 Infrastructure and Privatization Projects

The firm has developed a team to assist contractors, developers, technical experts and financiers participating in Thailand's privatization of infrastructure projects. We handled the privatization of the Rayong and Khanom Power Plants which was the first privatization project of its kind. We represented TT&T Public Company Limited in its project to install and operate the 1 million telephone lines outside Bangkok. We represent the Bangkok Mass Transit System PCL, the operator of the "Sky Train".

There are numerous other services not listed above which relate to business and industrial activities that we provide.

3.10 Insurance

Work involves advising insurance clients in connection with compliance with insurance laws and regulations, interpretation of policies, litigating claims, and handling investments and loans. We represent the Underwriters at Lloyd's in connection with aviation claims. (See, also, 3.21)

3.11 Information Technology Services

Internet Banking

We have assisted many well known banks to establish Internet Banking System, drafted and reviewed terms and conditions of internet banking services and advised on legal exposure of electronic financial transactions. In addition, we provide legal advice on commercial and business transactions through E-Commerce and Internet.

General Electronic Commerce Transactions

Our attorneys regularly handle sophisticated legal matters related to E-Commerce transactions which are fast increasing in Thailand. These include auction website, financial website, shopping on-line, Electronic Data Interchange (EDI), Digital Signature, insurance on Internet, taxation on Internet, venture capital on dot com company, Merger & Acquisition on Internet, Internet Service Provider (ISP), Value Added Network (VAN), etc. Among our major accomplishments was drafting and finalizing the SANOOK.COM Website Purchase Agreement which is regarded as the first merger & acquisition of a Thai website. Furthermore, we also represented the first national provider of Electronic Data Interchange (EDI) in Thailand to establish an infrastructure of EDI system in Thailand for Value Added Networks (VANs) and end users.

Computer Crime and Domain Name Dispute

Our litigation team has handled a number of computer crime cases, i.e., hacker, spamming, domain name dispute, gambling on Internet, etc. Cases of special interest handled by our litigation team were website hackings (www.sanook.com and www.narak.com) and domain name dispute with respect to www.tsutaya.com, the latter being the first domain name case in Thailand.

3.12 Labour

Work in this field involves advising and assisting clients in labour matters involving compliance with labour protection and labour relations law, preparation of work rules and litigating cases in the Labor Court, etc.

3.13 Litigation & Arbitration

Our team of litigators is regularly engaged to handle the more sophisticated litigation matters arising in Thailand. These include commercial disputes, property matters and major aircraft and maritime casualty incidents. Also, we have extensive experience in handling domestic and international arbitration matters.

3.14 Mergers, Take-Overs and Acquisitions

The firm has extensive experience in mergers, take-overs and acquisitions of both private and public-listed companies, mostly on the acquirers' side. The work involved the performance of due diligence investigations, handling bidding process, tender offers and other formalities with the Securities Exchange Commission and the Stock Exchange of Thailand, as well as preparing the necessary documentation to effect the change in ownership and the taking of necessary corporate actions, etc.

3.15 Mineral Resources and Energy

Work on the mineral resources side involves advising clients on the acquisition of exploration areas and operation of mines and compliance with the Minerals Act, environmental and forestry laws. On the energy side, we advise oil and gas companies in connection with petroleum exploration and production, refining and marketing in Thailand. We also assist clients in reviewing concession applications and farm-out/in arrangements. We are also extensively involved in advising the petrochemical industries. We are familiar with the licensing and operation of Independent Power Producers (IPPs), Small Power Producers (SPPs) and Very Small Power Producers (VSPP), using alternative sources of energy.

3.16 Promotion of Investment

The firm advises foreign investors in connection with the obtaining of rights and privileges under the Investment Promotion Act. The firm produces the Thailand Business Legal Handbook (now in its 11th edition) for the Board of Investment.

3.17 Real Estate

Work in this field includes advising and assisting clients in the acquisition and sale of real property (commercial, industrial and residential), including the upgrading and division of land titles, conducting due diligence investigations, etc.

3.18 Securities

The firm has acted on behalf of fund managers, advisors, custodians and underwriters in connection with various Thai equity quasi-equity, debt instrument and related matters in addition to assisting foreign investors take positions in Thai companies on a joint venture basis. The firm assisted with public offerings of Thai companies in Thailand and the stock related issues of Thai companies placed on various international stock exchanges, the establishment and operation of mutual funds and unit trusts with Thai interests that have been placed on the New York, International (London), Singapore and Hong Kong Stock Exchanges as well as in the establishment and operation of closely held investment structures prior to public offering.

The firm has also worked with various foreign international equity houses in establishing equity and management positions in Thai securities houses. The Firm has participated in creating novel swap and derivative structures.

3.19 Taxation

This includes tax planning, interpretation of tax laws, regulations and double tax treaties, defending tax assessments and litigating tax claims. Taxes in this connection encompass all taxes relating to business and industry, e.g., income tax, VAT, Special Business Tax, local development and land taxes, stamp duties, customs duties and excise tax, etc.

3.20 Trademark, Patent, Copyright and Trade Secrets

Work in this field includes registration of trademarks and patents, protecting copyrights and trade secrets and contesting infringements before administrative agencies and the courts.

3.21 Transportation

The firm is local general counsel to major airlines in Thailand. We also represent the Underwriters at Lloyds of London in Thailand insofar as their airline related business is concerned. Thus, we are constantly handling various passenger and cargo claims.

On the maritime side, we advise well-known shipping lines on their operation in Thailand. The work includes dealing with legal problems of multi-modal transportation, corporate and tax planning, etc.

3.22 Criminal Law

We handle criminal law cases to the extent that they relate to our core practice of business law. As all regulatory laws (e.g. securities, customs, intellectual property, etc.) have penal sanctions, our practice in this area involves dealing with the regulatory authorities, the police, public prosecutors, the trial courts and the appellate courts.
